If you plan to bring an out-of-school guest to the dance, this guest must be **MUST BE REGISTERED in the Deans' Office by Wednesday, September 19, 2018 at 3:45 p.m.** There will be NO EXCEPTIONS to this deadline. Eaglecrest High School Administration has the right to verify the information provided on the contract and has the right to refuse admittance of any guest to the dance. No Middle School students and no guest age 21 or over will be allowed to attend the Homecoming Dance. EHS students must adhere to the eligibility requirement to attend, and bring a guest to the dance. In addition, Cherry Creek School District has a drug-free, alcohol-free, tobacco-free policy. All guests are expected to adhere to this policy. Your child may use this contract to complete the registration process.
